The Spartans

ANDREW J. BAYLISS, Senior Lecturer in Greek History, University of Birmingham

The myths surrounding Sparta are as old as the city itself. Even in antiquity, Sparta was a unique society, considered an enigma.

The Spartans who fought for freedom against the Persians called themselves 'equals' or peers, but their equality was reliant on the ruthless exploitation of the indigenous population known as helots. The Spartans' often bizarre rules and practices have the capacity to horrify as much as they do to fascinate us today: weak and disabled babies were said to have been examined carefully by state officials before being dumped off the edge of a cliff and cowards were ultimately shunned to the extent that suicide seemed preferable.

The truth behind these stories of the exotic 'other' can be hard to discover, lost amongst the legend of Sparta which was even perpetuated by later Spartans, who ran a thriving tourist industry that exaggerated the famed brutality of their ancestors.

There was also much to admire in ancient Sparta: the state provided an education system which catered even to girls, and Spartan society allowed women a clear voice, an unparalleled phenomenon in the pre-modern world.

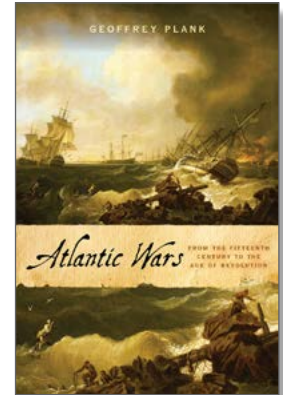
Atlantic Wars

From the Fifteenth Century to the Age of Revolution

GEOFFREY PLANK, Professor of Early Modern History, University of East Anglia

This title explores how warfare shaped human experience around the Atlantic from the late Middle Ages until the 19th century. Military concerns and initiatives drove the development of technologies like ships, port facilities, fortresses and roads that made crossing the ocean possible and reshaped the landscape on widely separated coasts. The pervasive influence of warfare on life around the ocean becomes apparent only by examining the Atlantic world as a whole.

- Provides an integrated analysis of warfare over centuries in the Atlantic world, including Africa, South America, the Caribbean, North America, and Western Europe.
- Discusses imperial conflicts over the creation of colonies, the transatlantic slave trade, and the revolutions across Europe in the 18th century.
- Includes material on the British, French, Dutch, and Spanish empires, as well as numerous indigenous African and Native American peoples.
- Incorporates first-hand accounts from sailors, soldiers, women, and children.

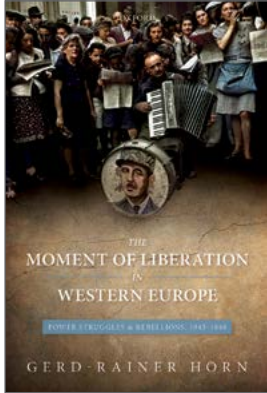
What is the point of history? Why has the study of the past been so important for so long? This volume contemplates two and a half thousand years of historiography to establish how very different thinkers in diverse contexts have conceived their activities, and to illustrate the purposes that their historical investigations have served.

Whether considering Herodotus, medieval religious exegeses, or 20th century cultural history, at the core of this work are the ways in which the present has been conceived to relate to the past. Alongside many changes in technique and philosophy, Bloxham's book reveals striking long-term continuities in justifications for the discipline.

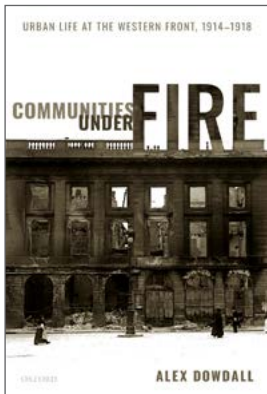

This volume focuses on the final two years of World War II and the immediate post-liberation period as a moment in 20th century history when the shape and contours of post-war Western Europe appeared highly uncertain and volatile, with various conflicting visions of the continent up for grabs.

Communities Under Fire Urban Life at the Western Front, 1914 - 1918

ALEX DOWDALL, Research Associate, University of Manchester

From Leningrad to Warsaw, Hamburg, and, more recently, Sarajevo and Donetsk, urban violence has remained a feature of warfare in Europe, turning cities into battlefields. On each occasion, civilian populations were at the heart of military operations, and forced to adapt to life in a warzone. As the first comprehensive study of civilian experiences at the Western Front on both sides of the conflict, this volume explores the impact of war, occupation, and displacement on civilian identities.

- Makes significant contributions to debates surrounding the militarisation of society in wartime and the role of civilians in the war.
- Draws on a vast array of archival sources, such as letters, diaries, and newspapers in English, French, and German.



Paramilitarism

Mass Violence in the Shadow of the State

UGUR ÜMIT ÜNGÖR, Associate Professor of History, Utrecht University

From the deserts of Sudan to the jungles of Colombia, paramilitaries have participated in violent conflicts in very different settings.

Paramilitaries are generally depicted as irregular armed organisations that carry out acts of violence against civilians on behalf of a state. In doing so, they undermine the state's monopoly of legitimate violence, while at the same time creating a breeding ground for criminal activities, so why do governments with functioning armies and police forces use paramilitary groups? The author interprets paramilitarism as the ability of the state to outsource mass political violence against civilians that transforms and traumatises societies.

- First comparative and conceptual synthesis of paramilitarism.
- Examines the involvement of organized crime in paramilitarism.

The Politics of Mass Violence in the Middle East

LAURA ROBSON, Professor of History, Portland State University

The Middle East's emergence as a 'zone of violence', characterised by a viciously dystopian politics of identity, is a relatively recent phenomenon. However, despite these shallow historical roots, the mass violence and dispossession now occurring in countries such as Syria, Lebanon, Israel, Palestine, and Iraq have emerged as some of the 21st century's most intractable problems. In this first history of mass violence in modern Middle East, the author uses a framework that investigates the expansion of this phenomenon across the Eastern Mediterranean, and illuminates the contemporary breakdown of the state from Syria to Iraq and Israel.

- Relates Middle Eastern studies to histories of genocide, ethnic cleansing, and other forms of mass violence.
- Treats the region as an integrated 'zone of violence'.

The Lockhart Plot

Love, Betrayal, Assassination and Counter-Revolution in Lenin's Russia

JONATHAN SCHNEER, Professor Emeritus, Georgia Institute of Technology

During the spring and summer of 1918, with World War I still undecided, British, French and American agents in Russia developed an audacious plan. Led by Robert Hamilton Bruce Lockhart, they conspired to overthrow Lenin's newly established Bolshevik regime, and to install one that would continue the war against Germany on the Eastern Front.

This is a deeply researched and rivetingly written work, but also a true historical thriller, a romance and a spy story.

- This is also the only full-length book on the Lockhart Plot, opening up this fascinating story to the world.
- Informed by never published before interviews, it presents a significant new interpretation of the subject.

The German Revolution

ROBERT GERWARTH, Professor of Modern History, University College Dublin and Director of the Centre for War Studies

The German Revolution of November 1918 is nowadays largely forgotten outside Germany. It is generally regarded as a failure, a missed opportunity which paved the way for the rise of the Nazis and the catastrophe to come. However, the author argues that to view the German Revolution in this way is a serious misjudgment. Not only did it bring down the authoritarian monarchy of the House of Hohenzollern, it also brought into being the first ever German democracy in an amazingly bloodless way.

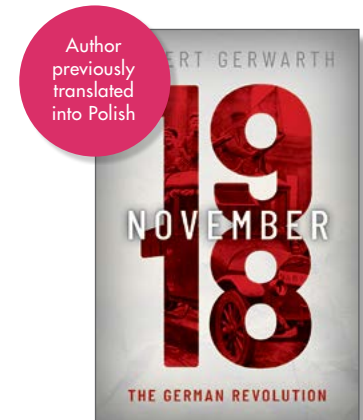

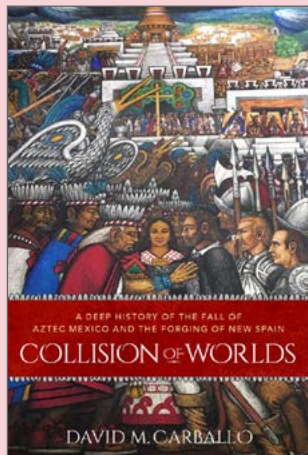

Collision of Worlds

A Deep History of the Fall of Aztec Mexico and the Forging of New Spain

DAVID M. CARBALLO, Director of the Archaeology Programme, Boston University

Five centuries ago, Mexico was witness to one of the most momentous encounters between human societies, when a group of Spaniards led by Hernando Cortés joined forces with tens of thousands of Mesoamerican allies to topple the mighty Aztec Empire. It served as a template for the forging of much of Latin America and began the globalised world we inhabit today. This violent encounter and the new colonial order it created, a New Spain, was millennia in the making, with independent cultural developments on both sides of the Atlantic and their fateful entanglement during the pivotal Aztec-Spanish War of 1519-1521.

This volume offers a unique perspective on this collision through its temporal depth and unique focus on the physical world of places and things, their similarities and differences in trans-Atlantic perspective, and their interweaving in an encounter characterised by conquest, colonialism, and the active agency and resilience on the part of Native peoples.

- Publication set to coincide with the 500th anniversary of the fall of the Aztec Empire (1519-1521).

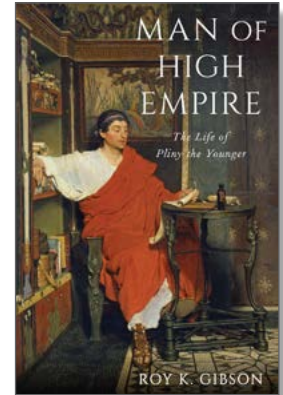
The Life of Pliny the Younger

ROY K. GIBSON, Professor of Classics, Durham University

Organised geographically, this volume is the first full-scale biography devoted solely to Pliny the Younger (c. 60-112 C.E.). Senator and consul in the Rome of Domitian and Trajan, eyewitness to the eruption of Vesuvius in 79 C.E., and early 'persecutor' of Christians on the Black Sea, Pliny the Younger remains the best documented Roman individual (other than emperors) between Cicero and Augustine. His individuality can be captured by focusing on the range of locales in which he lived: from his hometown of Como in the north of Italy, through the villa and farms he owned in the region of Umbria, down to the senate and courtrooms of Rome, as well as his magnificent residence on the coast near the capital.

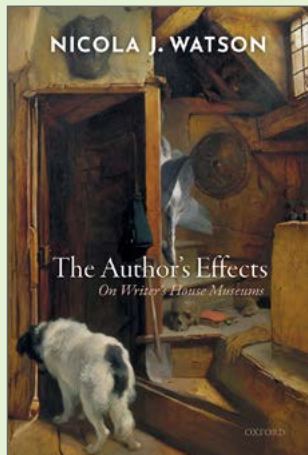

The Author's Effects On Writer's House Museums

NICOLA J. WATSON, Professor of English Literature, Open University

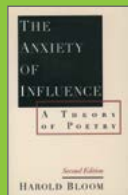
This is the first book to describe how the writer's house museum came into being as a widespread cultural phenomenon across Europe, North America, and Britain. Nicola Watson traces how and why the writer's bodily remains, possessions, and spaces came to be treasured in the late 18th and 19th centuries.

Delving into the archives of over 100 museums and archives to tell the tales of celebrated relics, Watson unearths the hidden stories behind Burns' skull, Keats' hair, Petrarch's cat, Poe's raven, Brontë's bonnet, Shakespeare's chair, Austen's desk, Woolf's spectacles, Hawthorne's window, Freud's mirror, and Bulgakov's stove, amongst many others.

Watson goes on to investigate houses within which 19th century writers mythologised themselves and their work—Thoreau's cabin and Dumas' tower, Scott's Abbotsford and Irving's Sunnyside. She also tracks literary pilgrims of the past to such long-celebrated literary homes as Petrarch's Arquà, Rousseau's Ile St Pierre, and Shakespeare's Stratford.

- Considers the writer's house museum as a form of literary biography crucial to the construction and maintenance of authorial celebrity.
- Explores how imaginative literature has produced the celebrity of physical objects and places.

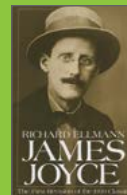

The Innovation Complex

Cities, Tech, and the New Economy

SHARON ZUKIN, Professor of Sociology, CUNY Graduate Center and Brooklyn College

Much is said about “innovation and entrepreneurship” and about how “good jobs” in tech will save our cities. Yet these common tropes hide a stunning reality: local lives and fortunes are tied to global capital. This can clearly be observed in cities such as San Francisco and New York, that have emerged as “superstar cities.”

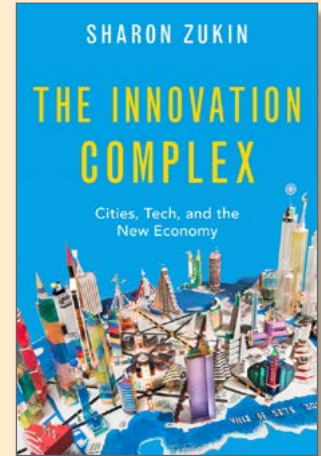
Eminent urbanist Sharon Zukin draws on original interviews with startup founders and venture capitalists, meetings with tech evangelists and economic development officers, and explorations of the subculture of hackathons and meet ups to demonstrate how these forces shape the new urban economy. In cities such as these, startups bloom, jobs of the future multiply, and a meritocracy trained in digital technology, backed by investors who control deep pools of capital, forms a new class: the tech-financial elite.

Using several case studies far beyond Silicon Valley, Zukin shows how cities like New York are shaped by an influential “triple helix” of business, government, and university leaders—an alliance that joins C. Wright Mills’ “power elite,” real estate developers, and ambitious avatars of “academic capitalism.” As a result, cities around the world are caught between the demands of the tech economy and communities’ desires for growth—a massive and often—insurmountable challenge for those who hope to reap the rewards of innovation’s success.

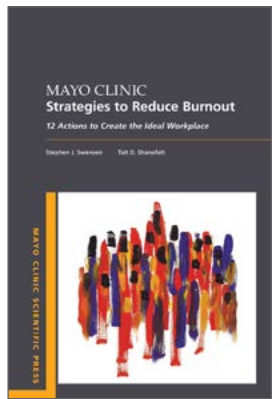

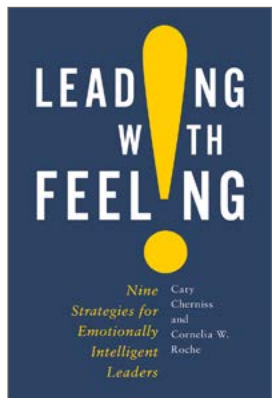

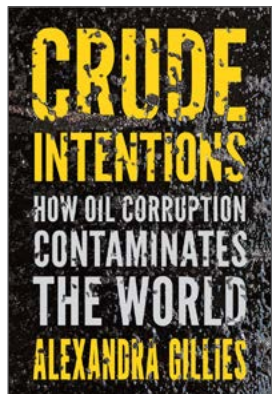

Space Expansionism, Planetary Geopolitics, and the Ends of Humanity

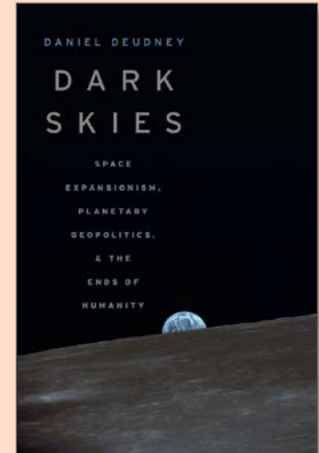
Planet Earth, tiny and fragile, and teeming with astounding life, is surrounded by an utterly desolate and inhospitable wilderness stretching at least many trillions of miles in all directions. Daniel Deudney stresses that our focus must be on Earth and nowhere else. He believes that the major result of the “Space Age” is the increased likelihood of global nuclear war and, as nuclear-armed ballistic missiles are inherently space weapons.

Mind-bending and profound, *Dark Skies* challenges virtually all received wisdom about the final frontier.

- Argues why space colonisation poses a significant threat to human survival and should be avoided, contrary to the widely-held view that space expansion is necessary to ensure the survival of humanity from mega-disasters on Earth.
- Examines space advocate arguments about Earth, technology, and world government in the context of great debates about the future of the planet.

Hatred

Understanding Our Most Dangerous Emotion
